



**Consent of personal data subject to the collection, processing,  
and transfer of personal data**

in accordance with Article 9 of the Law of the Kyrgyz Republic "On Personal Information," freely, specifically, unconditionally, and knowingly give consent to "**O!Bank" OJSC**, TIN 01204199910016, legal address: Kyrgyz Republic, 720033, Bishkek city, Frunze street 390, (the holder (owner) of the personal data array), for:

- automated, as well as non-automated or mixed processing of personal data, namely: collection; recording; systematization; accumulation; storage; updating; extraction; use; transfer (provision, access); grouping; anonymization; blocking; deletion; destruction;
- transfer of my personal data to third parties in accordance with the Law of the Kyrgyz Republic "On Personal Information" and international agreements, including cross-border transfer of personal data (transfer by the holder (owner) of the personal data array to holders under the jurisdiction of other states);
- verification of my personal data through state information systems and/or other data sources with open or special access for the purpose of obtaining banking services;
- receiving (transferring, providing) my personal data (information) about me from any state and non-state bodies and/or from any other available data sources in accordance with the legislation of the Kyrgyz Republic;
- other actions provided for by the current legislation of the Kyrgyz Republic.

The list of personal data for which consent to collection and processing is given: surname, first name, and patronymic (previous surname, first name, patronymic, date, place, and reason for change - in case of change of surname, first name, and patronymic); date of birth; personal identification number (PIN) and (or) individual tax number; gender; marital status; citizenship information; place of birth; nationality (if present in the identity document); address of registration; actual place of residence; details of the identity document (type, series, number of the identity document, name of the issuing authority and department code, date of issue, expiration date of the document); photo image of the identity document; personal photograph and (or) personal video image, personal photograph and (or) personal video image with the identity document; digital form of the identity document obtained through a special scanning device, which is a wide range of scanners, storage systems, computers, applications, servers, and other auxiliary devices; phone number (subscriber number); email address; tax residency information; information about the conducted activity (address of activity, economic sector, type of activity, expected turnover, legal address, etc.); photo image of the individual entrepreneur registration certificate/patent; details of the individual entrepreneur registration certificate/patent (registration number, OKPO, date of issue of the document, date of primary registration); information on income, expenses, property, and property obligations; information on tax registration and the amount of tax liabilities regarding movable (immovable) property, including information about the property itself; information about a public official within the limits established by the Regulations on the procedure for conducting due diligence of a client; information about the beneficial owner within the limits established by the Regulations on the procedure for conducting due diligence of a client.

The purpose of personal data processing is:

- providing access to remote banking service channels;
- verifying the accuracy of the information provided by me;
- obtaining personal data from other authorized sources;
- opening and servicing bank accounts and bank payment cards;
- improving customer experience, the quality of "O!Bank" OJSC services, the hardware and software complex used by "O!Bank" OJSC in providing banking services;
- other purposes that will be specified in the agreements concluded between "O!Bank" OJSC and me regarding the provision of banking products and services, and other documents.

Hereby, I acknowledge and confirm that, if it becomes necessary to provide my personal data to a third party to achieve the stated purpose(s), "O!Bank" OJSC has the right to disclose information about me and my personal data to such third parties and other authorized persons to the necessary extent for the aforementioned actions, and also to provide such persons with relevant documents containing such information, provided that the confidentiality of the data is properly maintained by the said persons.

I also hereby consent to the transfer of my personal data to third parties in accordance with the procedure established by the legislation of the Kyrgyz Republic. The form of notification about the fact of transferring my personal data to a third party is determined independently and at the discretion of "O!Bank" OJSC.

I am aware that:

1. Consent to the collection and processing of personal data is valid from the date of signing this consent for 1 (one) year from the date of providing this consent;
2. The list of my rights as a personal data subject includes the right to access my data, correct it, delete it, and cease its processing;
3. Consent to the processing of personal data can be revoked based on a written statement in any form.
